Or, have the New Yorkers fuzzy-indifference related to the existent 'local asserted' stance and/or related to the near future existent 'Indicatorial Comparatively asserted' stance?

Indifferent of the situation -but considering that the INDICATORIAL EVOLUTION is somehow asserted-then, it stands up a great-new COGNITIVE and PRAXIS-ACTIONAL context, and let the COMPARISONs effect to be open. Would all these influences, at least, to the LEADERSIP of the respective Smart City? I.e. {other plans/programs; other objectives; other experts/other positions-jobs; other city-style; 'originality' ...}!?! 


Fig. 1. The fourth and the first covers of a cited book into the 'References' [i.e. Nicolae Bulz's book on 2017].

direct effect of the just casted of a huge cannon and other innovative pieces of artillery – there was realizing a breach into the Constantinople's medieval multiple land stone-wall.

The SIEGE PARADIGM of city walls was replaced by the paradigm of a new standing artillery.

It was a surprising siege [and not the first] alongside 'incredible' -today- medieval thinking-lines within an operative thematic of spiritual "unity" into the 15th century Europe – that was conditioning of a necessary military help from the Western European Kingdoms. But the negotiation was ephemerally standing between mostly the too conservatively representative figures of the Eastern and Western Christian Churches.

Could this subtle 'standing far away' persists – and/or would survive within the 21st century? – but afterwards?

- -- Prussian war theorist Carl von CLAUSEWITZ (1780-1831) \parallel "On War" / published: 1832.

These sets of works had had within their role, within their epoch, within 'their public', ... - but significantly 'within' re-rolling into stepping forward the current

/ contemporary European Political Science(s), and respectively Military Theory and Praxis.

Into a no (detailed) comment stance, it is to affirm, only, on a (quasi-)present in effects situation, but with no nominal pointing, that there were, also, other outstanding personalities (scientists, writers and artists, religions representatives, philosophy representatives, ...) that (maybe with 'the best personal intentions and honesty' – initially, or even lately) 'but-an-but' the respective outstanding personalities consequently were dramatically / tragical contributed to the actual consolidated background [as a trace related to the contemporary 'WAR-PEACE-WAR' STANCE and current (observable and no-theorized)] of NO-POSITIVE EMULATION towards an 'ETERNAL PEACE' TRACK for our Contemporary World...

It is a malign stance (far from a step-by-step towards another benign stance) — But this 'malign'-attribute [related to what would be the 'EARTHLY SOCIETAL CORPUS' construct] is not an unanimously Earthly appearance — as an EARTHLY LARGE SCALE SOCIETAL AWARENESS and INSIGHT on.

Consequently, there is not an Earthly large scale societal correlated and concordant action — as coherent and cohesive to the PEACE — in order to prevent/modify/redress the respective MALIGN stance of our Contemporary World...

Into this problematic context, there is some lines of affirmation referring (only) the upwards-respective two just controversial case studies:

- * Niccoló MACHIAVELLI's: {"The Prince" (1513 / published: 1532), "Discourses on Livy" {Discourses on the First Ten Books of Titus Livy [Discorsi sopra la prima deca di Tito Livio]} / published: 1531; "The Art of War" (1521)} are standing to the epistemic nucleus and the decades after decades of research, related pedagogical research followed by largely distributed publications as q basement of the contemporary University and High School courses of Political Science and a 'must' of the gnoseological-essence of a statistical-elicited-contemporary-human.
- ** Carl von CLAUSEWITZ's: "On War" / (posthumous published by his wife: 1832)

So, here and now, it is presented a personal opinion that almost there is noteacher, no-University personality, no adjacent-statistical citizen to consider the 'malign' facet of the content of these 'initial' opuses for the course of the political life [from Renaissance towards our days of a warpeace-war stance...].

The 'result' is a set of cohorts of 'war like specialists'... and there is a too easily, and too early, enrolment towards the too open 'gates' of ascending towards the concealing the political class's members... [by this set of cohorts as very young graduates —bachelors—masters—doctors— in Political Science and/or Political Sciences].

[Firstly 'why?'. That because there is no a teaching personality to alarm on the social dangerous consequence if and only if you [future political specialist, future political councilor, future high-level leader] take statutory to JUST follow up Machiavelli's Renaissance-political behavior advice — without any doubt, without any rational appeal and contemporary political analysis...].

[Secondary approaching the case: Maybe an equivalent stance exists for a discipline as "Manipulation—theory and praxis"; if it is part of a university curricula than it could be taught to a younger generation only and only as a set of information of a today real case on, but advertising, and pledging on no-using its 'state-of-art' in any of a social context…]

The Renaissance differs from the contemporary period (a quasiturmoil period) - first of all by a NON-LINEAR COMPLEXITY...; "paying" 'beauty' to be BEAUTY, ... MORALITY, ... VALUE, ... PRAXIS – and consequently 'the emergent CONTEMPORARY (e-)TRUTH' – that there is not probable and possible a today linear societal event at all / 'within' all our RISKS and UNCERTAINTY (concepts that are studied with a NON-SYSTEMATICAL APPROACH, and without an effective and efficient minimal 'SYSTEMS THEORY AND PRAXIS' involvement.

- So, there is a CHAOTIC APPROACH [or in the best case a 'LEXICOGRAPHICAL PREVALENCE'] and consequently with a luck of great-great remaining standings [at the comparative standing 'levels' related to MACHIAVELLI and von CLAUSEWITZ].

<< What is Truth?>> is not standing more; maybe, if today ..., than Jesus would be ...?!?

'Fragility' does not remain the 'highest' human attribute...!?!

But for a human-machine entity ...??? Versus Netflix-subtle-portfolio, maybe will be elicited another human-machine cultural stance — sure that a high-level cultural reality would follow.

Let affirm, here and now, and present also a personal opinion on an equivalent -in all upwards pointed aspects for the Political Science(s)- situation for the Military Strategy Science and Praxis.

 - --- not-local world of "Renaissance small countries of chivalry battle field" and respectively
 - --- "a no-Illuminist world of no-Napoleonic pan-pseudo-European wars / no-wars of post-Medieval 'chess towards battle fields' " ...

So and so, Niccoló MACHIAVELLI and respectively Carl von CLAUSEWITZ just were not prefigurated our today Earthly too competitive, and too frequent too conflictual world (now of just again-two or more super-powers) – where their works would be a kind of 'Earthly societal cognitive and actional teaching poison'...


